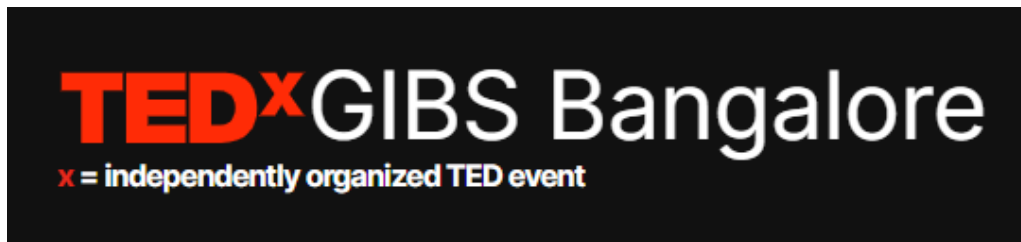

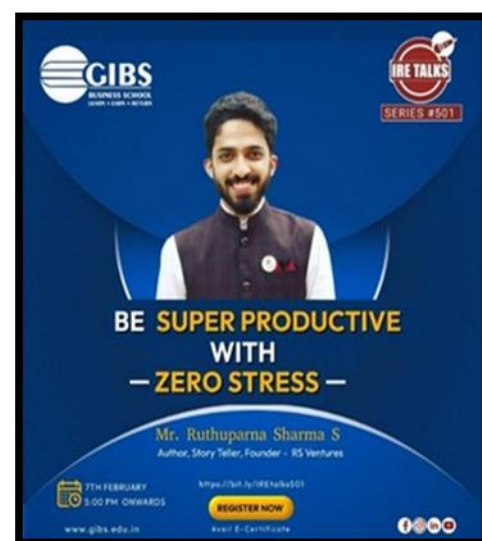


IRE TALKS

RESEARCH SERIES



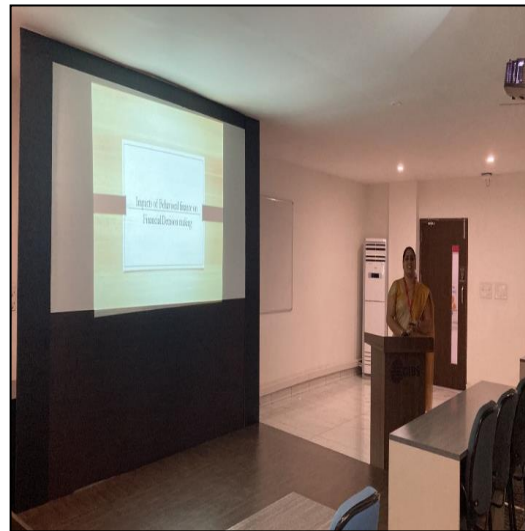

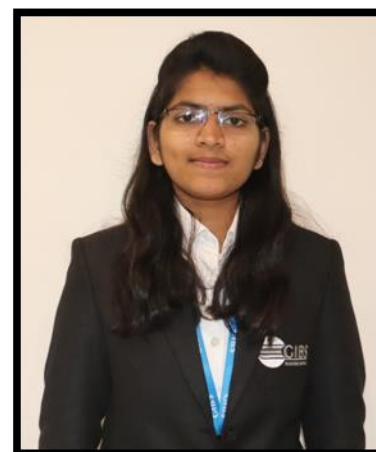
